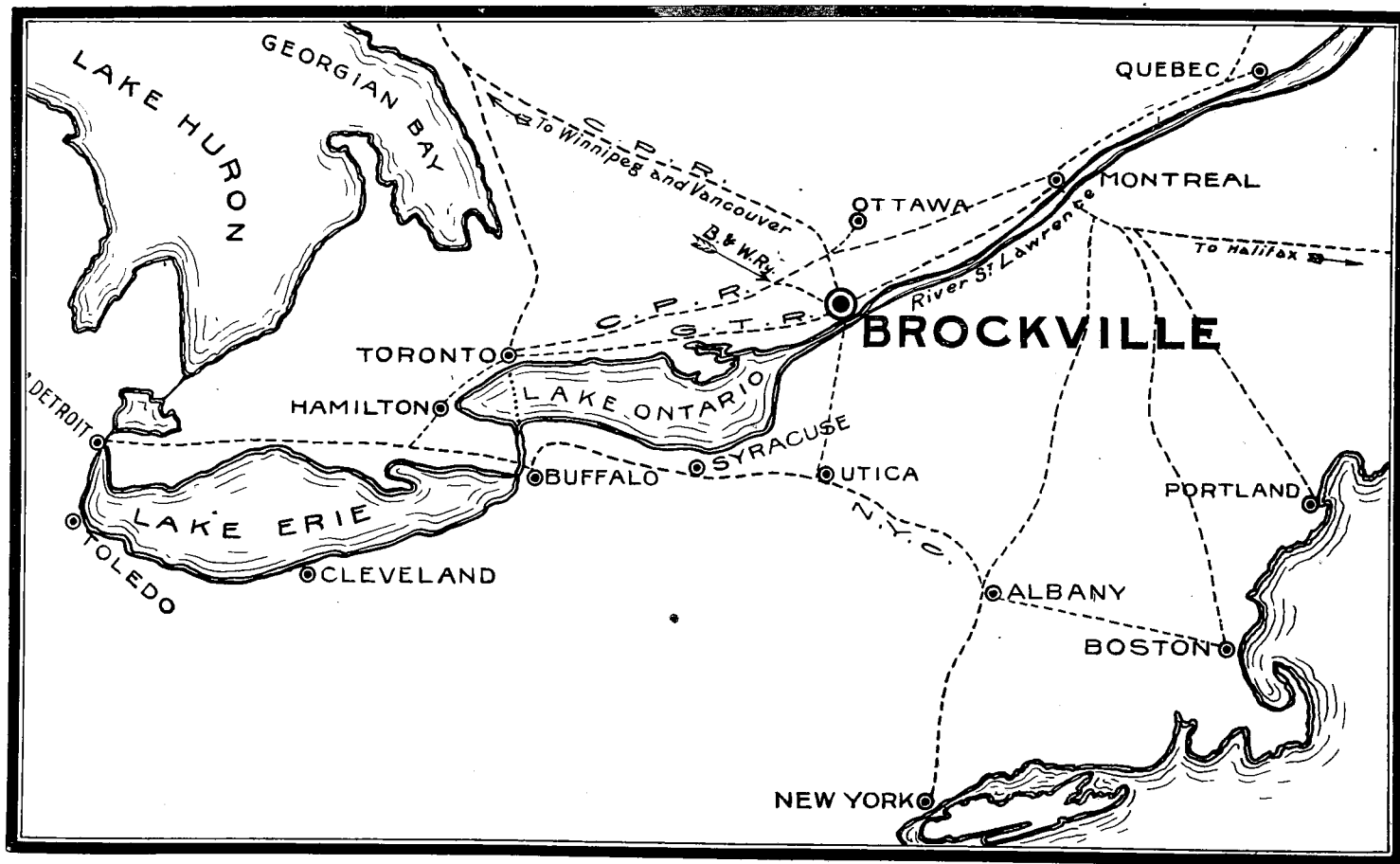

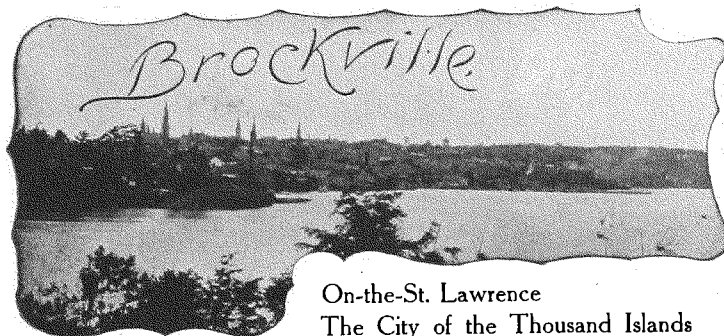

**The 1000 Islands** Brockville is beautifully situated on the river St. Lawrence, at the eastern gateway to the famous Thousand Islands.

**Close to New York** Brockville is the nearest Canadian town to Toronto, Montreal and Ottawa. New York City, with which it has excellent connection by ferry, to N. Y. C. fast trains at Morristown, N. Y. It is centrally located from Ottawa, 74 miles; Toronto, 208; Montreal, 125; New York, 362 miles.

**By Rail or Water** The transportation facilities by rail to all parts of Canada are first-class, there being connections with G. T. R., C. P. R., and C. N. R., also large public wharves at river with over 20 feet depth of water. The largest passenger and freight steamers stop at Brockville, going east or west.

**Big Dairy Section** Brockville has a world-wide reputation in dairy industries. The amount of cheese sold by the Dairymen's Board of Trade here, exceeds three million dollars annually.

**Factory Inducements** Brockville has already a number of factories employing from 200 to 400 hands each, besides lesser ones. Brockville offers free site and exemption from taxation, except school tax, for 10 years.

**Municipally Owned Plants** Brockville has water, light and power plants, municipally owned, and supplies consumers at about cost. A contract has been made recently with the Hydro-Electric Commission for additional power, which can be increased to any amount required.

**General Information** Brockville's population is about 10,000. Its postal revenue heads the list of towns in Ontario. Brockville possesses two public parks; athletic grounds; rowing, bowling, skating and curling clubs; golf links; two theatres; public library; two hospitals, besides the large Ontario Hospital for the Insane; six banks; two daily and weekly newspapers; fourteen churches; five public schools, separate school, schools for manual training and domestic science, St. Alban's boarding school for boys, collegiate institute, business college; county court house; Board of Trade; Commercial Travellers' Club. Brockville has first class hotel accommodation. Brockville has a municipal system for the collection and disposal of garbage. Brockville has an Isolation Hospital. Brockville has regular and scientific inspection of the milk supply. Brockville has a complete sewerage system, about 30 miles of granolithic sidewalks and its principal streets paved with asphalt.

**Financial.** That Brockville holds a prominent place in the financial world is shown by the presence of so many banking institutions. There are six banks represented, as follows: Bank of Montreal, Bank of Toronto, Canadian Bank of Commerce, Molsons Bank, Metropolitan Bank, Northern Crown Bank, as well as the Brockville Loan and Savings Company which gives the manufacturer and merchant the advantage of handling large transactions in a satisfactory manner.

**Brockville** is the County Town of Leeds and Grenville Counties. It is the home of the county officials, and has a very imposing court house and county buildings.

**Fire Protection** Brockville has an efficient fire brigade with complete hydrant system, elegant new fire station, chief, captain and firemen. The insurance rate is as low as any of the cities of its size in Canada.

**Police** Brockville has a capable and well organized police force consisting of a chief, sergeant and police constables, who keep close watch and protection over the property and rights of its citizens in general.

**Newspapers** Two daily papers are published in Brockville—the Recorder and the Times. Editions of the Recorder are published every afternoon, as well as a weekly edition, and afford to advertisers the largest circulation of any daily paper between Kingston and Montreal. The job printing department of the Recorder is not excelled in the perfection of its equipment, and is prepared to handle any job of printing be it large or small. The Times is a daily as well as a weekly also well equipped job department and book bindery in connection. The management of these papers are always interested in the welfare of the city and do everything in their power to further the general advance and interests of Brockville.

**A Sportsman's Paradise** For 10 miles west of Brockville the river bank and islands are studded with handsome residences and summer resorts, to which a local steamer plies several times daily. The fishing is good; black bass, pike, etc., and within four miles from Brockville is the favorite haunt of the largest masginnonge of the St. Lawrence. Within two hours ride inland, by the C. N. R., is a long chain of lakes; the Rideau, Beverley, Charleston, etc.—a paradise for anglers.

**The Moral Effect** Employees in the factories, as a rule, locate permanently in Brockville and own their homes, and its citizens are happy and prosperous.

**Brockville Country Club** Situated about a mile west of the town, easy of access either by road or by water. Will have an artistic bungalow club house on the river St. Lawrence near "Swift Waters," from which a glorious view of the islands both up and down the river can be obtained. On this part



of the property tennis courts will be laid out while a private road leads through to the golf links where a professional is in attendance. The course will be one of the best sporting nine hole courses in the country, being naturally adapted for the formation of golf links, and in time could be increased to eighteen holes if desired. It is expected that teas and luncheons will be served on the verandah or in the diningroom of the club house, so that the Country Club will be an inestimable boom to the town from a social as well as a sporting point of view. **Brockville Community Men's Christian Association,** the idea seems to prevail that all that is necessary in order to solve the problem of their boys and young men is to provide some sort of reading rooms and gymnasium. The years of Association history, however, have proven that this is a mistake, and that the vital factor in any character building is a competent trained man. The Brockville type of work has met with gratifying results. It has demonstrated that work among boys can be successfully carried on through a Board of Directors consisting of a representative group of men and an experienced Boys' Work Secretaray working through and in co-operation with Home, Church, School, Municipality and other constructive agencies. In Brockville it has been demonstrated that an adequate and efficient work can be maintained among boys and young men without additional expensive equipment other than that which already exists, such as Schools, Public Halls, Churches, etc. The Movement strives to reach every need of every boy in the Community by its policy of co-operation with all constructive agencies. In this way many more boys are reached than could be through an expensive building. The work is also a great educational factor in the Community in solving the boy problem. After one year and nine months, and at a time of financial depression the citizens of Brockville have endorsed in a most practical way efforts put forth by the Movement, with its co-operative and unifying policies, by responding to a second financial campaign for the continuance of the work, when an even larger sum was raised

than at the time of its organization. This has given permanency to a work that Brockville and all other smaller cities should be conducting. Following are a few of the activities promoted and institutions established since the inception of the Brockville Community Work: Through the Home—"Father and Son" Banquets, "Mother and Daughter" Banquet, Parents' Mass Meeting, Women's Meetings, Summer Camp, Free Employment Bureau, Free Boarding House Register, Cultural Entertainment, Educational Lectures, Junior Section at Fall Fair in co-operation with Fall Fair Association, Victorian Order of Nurses in co-operation with the Daughters of the Empire. Through the Church—Hockey leagues, Baseball Leagues, Outdoor Athletic Meet, Indoor Athletic Meet, Century Hikers Club, Training Classes, Promotion of Teaching English to Foreigners, Conferences for Training Leaders, Boys' Work Conference. Through the Schools—Promotion of the "Wider use of the School Plant"; in co-operation with the Board of the Collegiate Institute the establishment of Free Evening Educational Classes, Free Evening Gymnasium Classes for Employed Boys, Practcial Talks to Employed Boys, Supervised Playground Work, Open Air Skating Rinks, Educational Campaign for Medical Inspection, Home and School Gardens, Physical Training Classes. Not only is the work molding more lives than it would be possible to do through a building in a town of this size; but it demonstrates an effective and economical method of getting actual results and citizens are receiving a greater return, through their extra use, from their costly Church, School and Public Buildings. The officers of the Brockville work are: T. J. Storey, Esq., President; H. A. Stewart, K.C., Vice President; J. P. Grant, Treasurer; W. H. Wood, Secretary. With Judge Reynolds, W. H. Kyle, J. S. 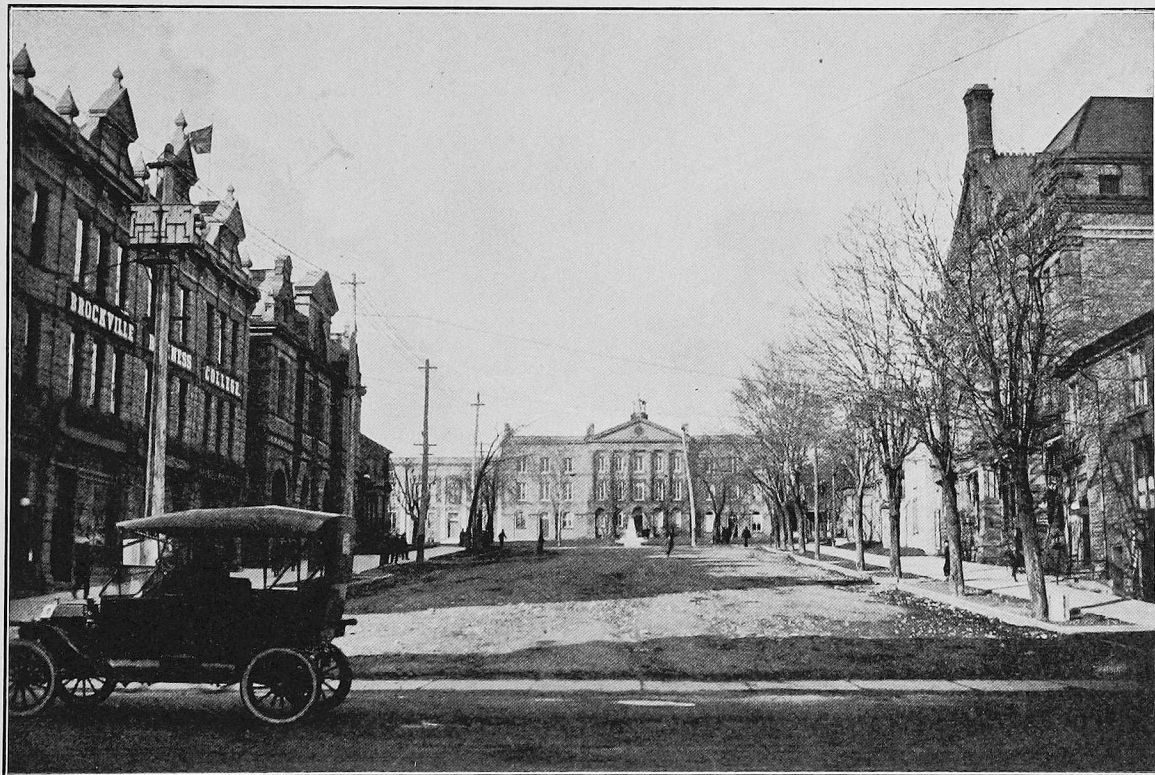

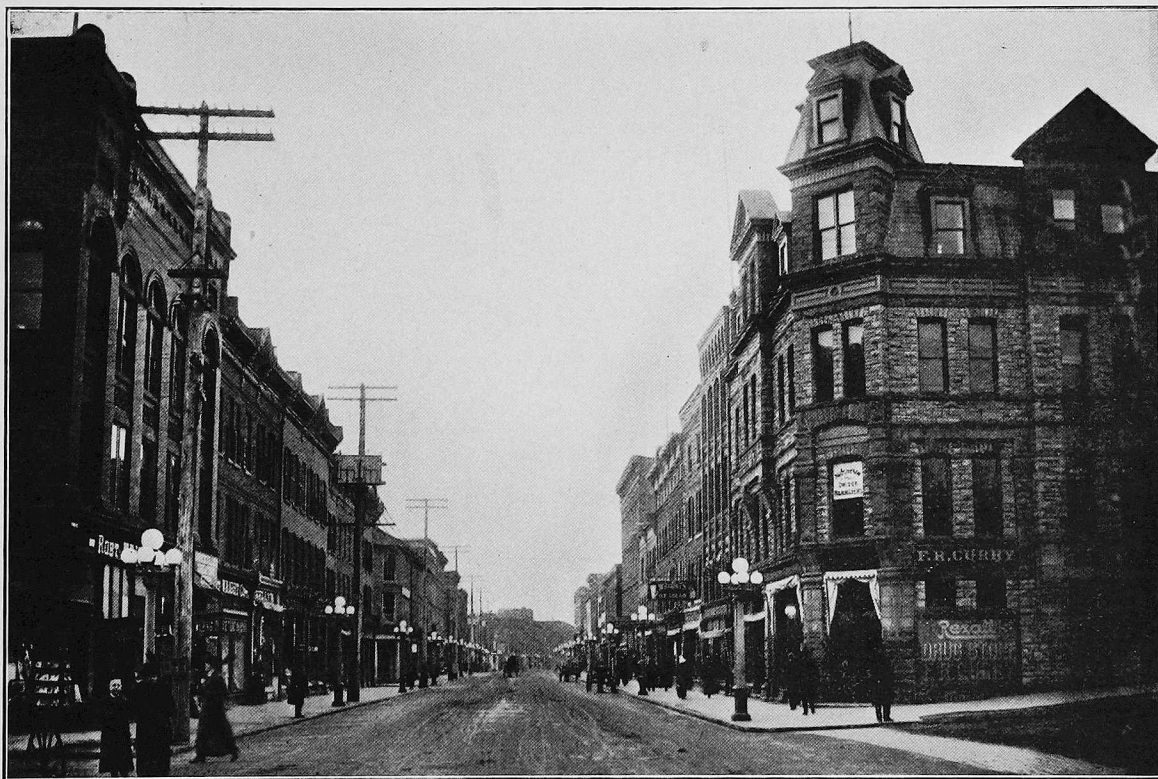

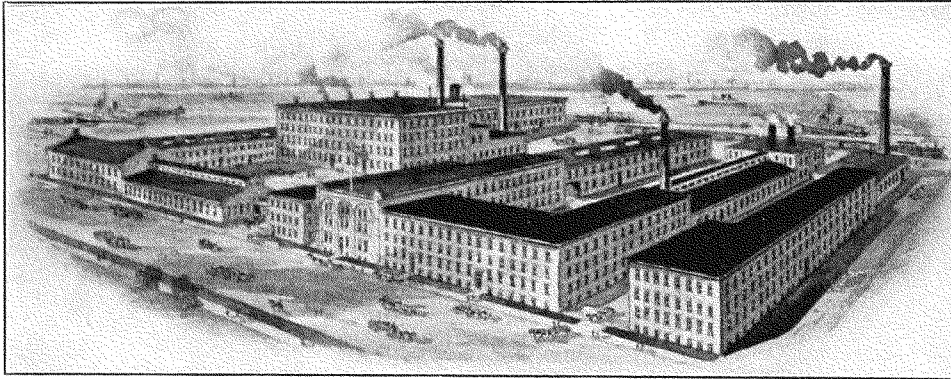


KING STREET LOOKING WEST FROM COURT HOUSE AVENUE

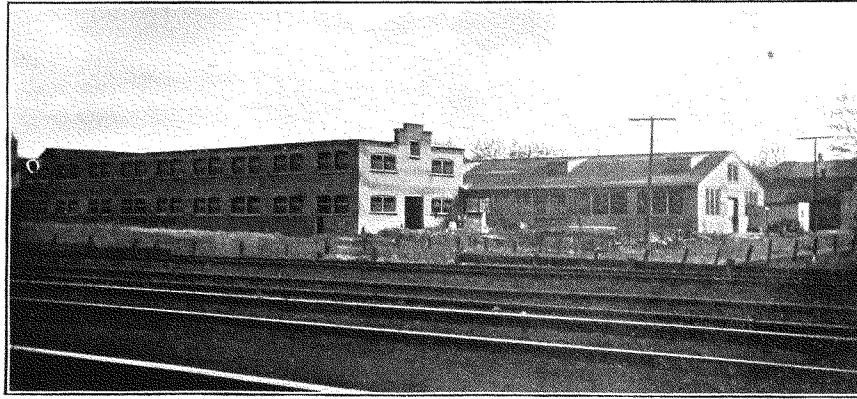




KING STREET LOOKING EAST FROM COURT HOUSE AVENUE
